

List of Participating Countries in the Single Market Programme (SMP)

EFTA countries which are part of the European Economic Area (EEA)

Internal Market strand (SMP COMP, etc)

- **Iceland, Norway, Liechtenstein** participate in the SMP Internal Market strand as from 01 January 2021, with the exception of the sub-strand "Taxud regulatory work support"

COSME strand (SMP COSME)

- **Iceland, Norway and Liechtenstein** participate in the SMP COSME strand as from 01 January 2021

Standardisation strand

- **Iceland, Norway, Liechtenstein** participate in the SMP Standardisation strand as from 01 January 2021, but only for the sub-strand "Support the development of high-quality international financial reporting"

Consumer strand (SMP CONS)

- **Iceland, Norway, Liechtenstein** participate in the SMP Consumer strand as from 01 January 2021. Exception for Norway not participating in "Enhancing the participation of consumers, other financial services end-users and civil society in financial services policy making"

Food strand (SMP FOOD)

- **Iceland, Norway, Liechtenstein** will not participate in the SMP Food strand

European Statistics strand (SMP ESS)

- **Iceland, Norway and Liechtenstein** participate in the SMP European Statistics strand as from 01 January 2021

EU Acceding countries, candidate countries and potential candidates

- **Albania** participates in the SMP Programme, but only in the strand for 'Competitiveness of SMEs' (*agreement signed in December 2023 – entry into force retroactive on 01 January 2021*)
- **Bosnia and Herzegovina** participates in the SMP Programme, but only in the strand for 'Competitiveness of SMEs' (*agreement signed in July 2023 – entry into force retroactive on 01 January 2021*)
- **Kosovo***¹ participates in the SMP Programme, but only for the following strands: 'Operation/Development of the Internal Market of Goods and Services', 'Competition Policy', 'Market Surveillance', 'Competitiveness of SMEs', 'International financial reporting' and 'Ensuring high level of consumer protection and product safety' (*agreement signed in May 2023 – entry into force retroactive on 01 January 2021*)
- **Montenegro** participates in the SMP Programme, but only for the following

strands: 'Operation/Development of the Internal Market of Goods and Services', 'Competition Policy', 'Market Surveillance', 'Competitiveness of SMEs' and 'Ensuring high level of consumer protection and product safety') (*agreement signed in April 2023 – entry into force retroactive on 01 January 2021*)

- **North Macedonia** participates in the SMP Programme, but only for the following strands: 'Operation/Development of the Internal Market of Goods and Services', 'Competition Policy', 'Market Surveillance', 'Competitiveness of SMEs' and 'Ensuring high level of consumer protection and product safety' (*agreement signed in April 2023 – entry into force retroactive on 01 January 2021*)
- **Serbia** participates in the SMP Programme, but only in the strand for 'Competitiveness of SMEs' (*agreement signed in September 2023 – entry into force retroactive on 01 January 2021*)
- **Türkiye** participates in the SMP Programme, but only in the strand for 'Competitiveness of SMEs' (*agreement signed in March 2023 – entry into force retroactive on 01 January 2021*)

European Neighbourhood Policy countries

- **Armenia** has confirmed interest to join the SMP Programme, but only in the strand for 'Competitiveness of SMEs'
- **Georgia** has confirmed interest to join the SMP Programme
- **Moldova** participates in the SMP Programme, but only in the strands for 'Market Surveillance' and 'Competitiveness of SMEs' (*agreement signed in September 2023 – entry into force retroactive on 01 January 2021*)
- **Ukraine** participates in the SMP Programme, but only in the strands for 'Competitiveness of SMEs' and 'Producing and disseminating high quality statistics on Europe' (*agreement signed in February 2023 – entry into force retroactive on 01 January 2021*)

Other countries

- Currently, no country has confirmed interest to join the SMP Programme
